

**CAMP LEJEUNE JUSTICE ACT (CLJA)  
CLAIMS AND DAMAGE: ANDREW U. D. STRAW & FAMILY**

**GENERAL SITUATION**

U.S. Department of Justice [says](#) that there are about **117,000 CLJA claims** at U.S. Navy JAG as of October 27, 2023, and that the total claimed is about **\$3.3 trillion**. This means the average claim is over \$28,000,000 each.

### CLAIM 10

LAWSUIT: NONE YET

INJURED CLAIMANT: **Andrew U. D. Straw**

DATES OF EXPOSURE: 12/19/1968 – 7/24/1970

- Elective Option Conditions, Undiagnosed as Yet (no screening so far)

### CLAIM 11

LAWSUIT: NONE YET

INJURED CLAIMANT: **Andrew U. D. Straw**

DATES OF EXPOSURE: 12/19/1968 – 7/24/1970

- Cardiac Birth Defect (VSD), noted in USN Medical & Birth Records
- There is evidence such birth defects may cause multiple mental illnesses.

### CLAIM 12

- Parkinson's Disease, Incipient Writhing Symptoms, Not Yet Diagnosed
