- Advocated for poisoned family members of U.S. Marines stationed at NAS Jacksonville, FL. Pursued First Amendment federal lawsuit in Wisconsin for free speech national leader to protect right to wave a US flag on a public sidewalk. Lawsuit for handicap access: 5 N. Illinois local governments.
